**Frozen semen is shipped directly from the storage lab in Michigan. Equine Cryo Facility will too require additional shipping and notification. Frozen semen is \$350 in addition to the stallion service fee plus any fees from Equine Cryo. Deposits are due on both fresh cooled and frozen containers. Fresh cooled Equitainer deposits are \$300 & \$1200 Frozen are refundable upon timely return of the container. After 7 days of receipt of the container you will be charged \$10 per day late fee for late return of the container. A licensed veterinarian will inseminate all semen shipped as a part of this stallion service contract. Failure to do so may null & void this contract and any monies paid will be fortitted. Should the stallion become unfit for service for any reason frozen semen will be substituted, 2 doses shipped one at a time or a pregnancy, which ever comes first will forfil the terms of this contract.

LIVE FOAL GUARENTEE

The owner of the stallion guarantees a live foal from the live mating & agrees to continue shipping semen for a period of Up to 2 years, at which time a substitute mare may be requested. A Live foal is defined as one that will stand and nurse. Should the mare abort, foal be born dead or fail to stand and nurse, a Statement of circumstances must be given in writing by the mare owner to the stallion owner/agent within 30 days post foaling. In such a case the agents of the stallion agree to breed or ship semen free of additional booking charges, additional shipping charges will still apply, during the current Breeding season. If the owners of the mare so choose to wait until the following breeding season an additional \$500 will be Due as a re-booking fee.

COLLECTION/SHIPPING FEE:

Owner shall pay a nonrefundable fee of \$350 plus fed ex shipping expenses costs to be billed per occurrence. This fee includes the use of either a disposable box/Equitainer. Breeder is not responsible for lost, delayed or otherwise damaged seen and makes no representations of warranties if any kind except that is the semen if the named stallion and that is was viable when it left the farm it shippers or agents.

EMBRYO TRANSPERS & TWINS:

If breeding by embryo transfers/twins & more that one foal is produced, additional breeding fees will be due JD Stables, LLC, for each live foal that is produced.

WAIVER OF LIABILITY:

It is understood that the owner of the stallion, Equine Cryo, owners, employees, and/or agents shall exercise good and reasonable judgement in caring for the mare and foal, if applicable, but shall not be liable for injuries, disability or death suffered by the mare &/or foal while in the care of custody of stallion owner Or it's agents. Semen is live and viable when it leave's the farm arrival of quality semen is not guaranteed once it has left the farm due to circumstances beyond our control.
