◆◆◆ Live Cover and Shipped Semen Breeding Contract for Morgan Mares◆◆◆

This contract is an agreement between \_\_\_\_\_ (mare owner) herein known as Owner, and Peggy Malone of Takilma Gold Morgans. All prices are in US Dollars.

THESE PARTIES AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

1.) Takilma Gold Morgan's agrees to breed Ragtime Oro Blanco, Perlino Morgan stallion, AMHA# 152944 to the following mare:

2.) The Stallion Service Fee for the 2023 breeding season is \$850.00. This includes a Booking Fee of \$200.00 which is nonrefundable, the booking fee is deducted from the stud fee and must be paid to confirm breeding reservation prior to breeding. This contract must be signed and completed with the mare's registration or lease papers attached for approval and submitted with the Booking Fee to reserve the breeding.

3.) The Collection & Shipping fees must be paid along with the balance of the Service fee \$650.00 before shipping or live cover. Shipping and collection fees for the 2023 breeding season will be approximately market price.

4.) Live foal guarantee: None of the above fees shall be refundable. However, stallion owner guarantees a return breeding the following season if conditions below are met:

a.) Mare must have ultrasound at 16-20 days post breeding as evidenced by a written statement from a licensed veterinarian.

b.) Live foal guarantee: If a live foal (defined as one who stands and nurses) does not result from this breeding, then the above-mentioned mare or an agreed upon substitute may rebred the following year. A written statement from a licensed veterinarian setting forth the details of abortion or of foal's death will be required. Normal collection and booking fees will apply for rebreeding.

5.) Mare care is 15.00 per day, 17.00 for mare with a foal. The foal must be halter broke.

6.) Shipped semen: Semen may be shipped to mare owners under AMHA rules and regulations under the following conditions:

a.) Entire breeding fee must be paid before live cover or semen can be shipped.

b.) A collection and shipment fee will be paid by the mare owner prior to each shipment. This fee includes shipping charges on normal (Priority Overnight) shipments by Federal Express or United Parcel Service.

c.) A 48-hour notice is mandatory for shipment of semen.

d.) Collection and shipping days are Monday thru Friday. This may be rearranged with a prior 48-hour request.

7.) Stallion Owner agrees to ship cooled semen as described above, including live cover. If the mare fails to settle for any reason, the mare owner will hold the Stallion owners and related parties blameless.

**Breeding:**

The mare owner agrees their mare is healthy, in sound breeding condition and is halter broke upon arrival. Mare owner will provide Peggy Malone of Takilma Gold Morgans with:

✓ Negative current coggins test if mare is from out of state

- ✓ Current vaccine record
- ✓ Negative uterine culture by a licensed veterinarian
- ✓ Copy of Registration papers
- ✓ Signed Copy of the breeding contract.

1. All parties agree to diligently try to settle the mare. Should the mare not settle, the mare owner will hold stallion owner harmless from any resulting loss or damages. Stallion owner shall not be liable for any injury, sickness, disease or death of mare or her offspring arising from the exercise of the breeding rights and privileges granted herein.
2. Mare care is an additional cost every time the mare or mare/foal return for breeding.
3. Mare owners must have shoes removed before breeding.
4. We strongly suggest that you have an ultrasound on your mare to confirm pregnancy at 17 days from the last breed date to ensure your mare is bred to Casper aka Ragtime Oro Blanco.
5. If the said mare is sold prior to foaling, without notice to stallion owner, live foal guarantee is null and void.
6. All signatures are required as they appear on the registration or lease papers, and a copy of the registration/lease papers must be attached.

PARTIES AGREE THAT ONLY THE ORIGINAL CONTRACT (AND NOT ANY COPIES) SHALL HAVE ANY FORCE AND EFFECT, ANY AMENDMENTS TO THE ORIGINAL CONTRACT MUST BE IN WRITING AND BE SIGNED BY ALL PARTIES TO BE EFFECTIVE.

THE TERMS OF THIS CONTRACT AS STATED ABOVE HAVE BEEN READ AND ARE ACCEPTED WITHOUT RESERVATION.
