### **2024 Breeding contract for LCS Pepperjack**

#### **Collection/Handling/Shipping Fee For Semen Transport:**

Mare owner shall pay a non-refundable collection/handling/shipping fee of \$300.00 to stallion owner upon execution of this contract, which must be executed and returned by mare owner prior to shipment of the semen. All subsequent shipment(s) of semen will be billed @ \$300.00 each by stallion owner.

All parties agree that semen shipped under this contract provides for the registration of one foal. If this shipment results in the birth of two foals, a stud fee of \$1,000 will be due within 30 days of foaling.

All parties agree that semen shipped under this contract will only be used to inseminate the mare named above.

If stallion passes away or is unable to produce viable semen, it will be the option of the stallion owner to provide frozen semen of said stallion. If the mare owner declines substitute stallion and/or frozen semen from original stallion, **all monies paid will be forfeited.**

If this contract pertains to a donated stallion service to a stallion service auction (I.E. - Michigan Morgan Auction, New York stallion service auction or Oregon Morgan Horse

Auction), the donation is good for one (1) breeding season from time of donation of stallion service.

### **Payments:**

All payments should be made to stallion owner, Musette Kyranos in the form of Certified Check, Money Order, Venmo or PayPal.

### **Return Privileges/Live Foal Guarantee:**

Mare must be examined by a licensed veterinarian at or before 15 days after last date bred, and stallion owner must be notified of her breeding status after each examination, or all guarantees are null and void. Should mare abort, absorb the fetus or fail to conceive, return privileges are guaranteed in the current season (March 15 through August 15) As well as the following breeding season from (March 15-August 15).

A substitute mare may be used upon approval of stallion owner. At the end of the current season, the owner of the mare shall have the option of rebooking in the following season, but contract is only valid for two full breeding seasons from time of contract. If the said mare (or substitute mare) doesn't settle within the two breeding seasons this contract becomes null and void and **all money paid is forfeited**. Should the mare fail to produce a live foal (defined as one that stands and nurses) return privileges are guaranteed for the following breeding season.

Rebooking in the following season, will require an additional collection/handling/shipping fee for fresh cooled semen transport.

### **Live Cover:**

Mare owner is to pay \$20 per day (beginning when mare arrives and ending when mare departs) for mare care to stallion owner. This fee includes: hay, grain, bedding, turnout, and general care of mare. Any veterinary care needed for mare during the duration of her stay, is the sole responsibility of the mare owner. The said mare owner cannot hold stallion owner and/or property owner responsible for any harm, injury, or death of mare/and any existing foal (by her side) resulting from any natural occurring injuries during a live cover breeding between said mare and stallion. Mare owner agrees, said mare is in good health and is fit for breeding at time of arrival. Mare owner agrees to provide a negative coggins report upon arrival to Salute Morgans Farm.

### **General:**

Should the mare fail to conceive, abort and/or abort the fetus, stallion owner agrees to provide return privileges for the following breeding season (March 15-August 15) with the same terms applying. Mare owner may substitute another mare for breeding. **No monies returned (and/ or) refunded if mare owner decides to not re-breed mare/OR substitute a mare.**

Upon completion and signing of this breeding contract, mare owner agrees to all terms and conditions of this contract. **Stud fee of \$1,000.00 is to be paid in full prior to**

shipment of semen. Further, the Stud fee is to be paid in full before any live cover stud services are rendered.
