TERMS AND CONDITIONS:

KERRY MORGANS agrees to provide two (2) doses of frozen semen from the above named stallion in exchange for a breeding fee of \$1250.00; \$500.00 of which shall be a non-refundable booking fee. All fees must be paid in full before semen will be released for shipment. These fee will be uncollected for the MHAO Stallion Auction purchaser.

Semen is stored at Oakhurst Equine. Mare Owner/Lessee agrees to pay all container fees and shipping costs and shall provide <u>OAKHURST EQUINE</u>, <u>18715 NE Hwy</u>. <u>240</u>, <u>Newberg</u>, <u>OR 97132</u> [phone #503-554-0227; fax #503-554-1317; email <u>Office@oakhurstequine.com</u>] with credit card information to cover such costs. Mare Owner/Lessee agrees to insure container for replacement cost during shipment at Mare Owner/Lessee's expense. Mare Owner/Lessee agrees to abide by the terms set by Oakhurst Equine in the shipping and return of the semen and semen container. The veterinarians at Oakhurst will provide detailed instructions for the thawing and inseminating of the frozen semen as well as consulting with the veterinarian responsible for the insemination.

It is strongly suggested that you have your veterinarian perform a breeding soundness exam on the mare before you breed her.

Kerry Morgans assumes responsibility to provide frozen extended semen doses in viable condition at the time of delivery to the Mare Owner/Lessee or his or her designee. Mare Owner/Lessee must employ a licensed veterinarian to administer doses. The two doses of semen in the first shipment is for use over 2 separate breeding cycles. If needed, a third dose of semen will be shipped during the same breeding season. A statement from the veterinarian listing all dates of breeding must be sent to Kerry Morgans for registry purposes.

If the mare dies or is deemed unfit to breed during the breeding season a substitute mare may be bred without any additional breeding fee.

ANY UNUSED SEMEN MUST BE RETURNED TO OAKHURST EQUINE AT MARE OWNER/LESSEE'S EXPENSE BY THE END OF THE BREEDING SEASON for storage for the stallion owner's use or the purchase of an additional breeding contract must be made.

The parties agree that the Mare Owner/Lessee shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare. In the event that inseminations using the standard (3) doses of frozen semen from the stallion indicated do not result in a live foal, as certified by a licensed veterinarian, Kerry Morgans will provide an additional (3) doses of frozen semen from the indicated stallion for insemination in the subsequent breeding season at no additional charge (except container and shipping charges which must be paid by the Mare Owner/Lessee).
