This contract is made by and between Stolen Aces Farm LLC (Seller) and \_\_\_\_\_  
(Buyer) for the express purpose of breeding of the Mare: \_\_\_\_\_  
(Registration # \_\_\_\_\_) to the Morgan Stallion **FARAGAMO GCH** AMHA Registration # 161254, for the  
2026 Breeding Season; subject to the following terms and conditions:

1. **PAYMENT:** Buyer is purchasing one (1) dose equal to 8 straws of Frozen Semen from Faragamo GCH. Semen is stored at Pioneer Equine Hospital in Oakdale, CA, a Select Breeders Service Affiliate Lab (Storage Facility). The non-refundable Stallion Frozen Semen Fee of \$1,000.00 is payable as follows:

- A) Non-refundable Frozen Semen Booking Fee of \$250.00 due at signing of this contract.
- B) \$750.00 due before frozen semen is authorized to be shipped.

In the event that Mare does not settle in foal, Buyer will be entitled to one further frozen semen shipment during the breeding season at the reduced price of \$500.00.

2. **RESERVATIONS FOR FROZEN SEMEN:** Seller's receipt of the Stallion Frozen Semen Booking Fee outlined in A above confirms the Mare's reservation to breed to the Stallion for the Breeding Season

3. **AUTHORIZATION FOR SHIPMENT:** Seller will provide Storage Facility with written authorization to release one (1) dose upon request from Buyer once payment B above is received. Frozen Semen should be ordered by the Buyer at a minimum of 48-hours prior to shipment.

4. **SHIPPING FEES:** Seller will provide Buyer with a Frozen Semen Shipment Request Form from the Storage Facility. Buyer is responsible for making the timely request for shipment and for all costs associated with shipping the frozen semen from Storage Facility.

5. **SUBSTITUTE MARE** is not allowed without prior written consent of Stolen Aces Farm.

6. **EMBRYO TRANSPLANTS** are prohibited without written permission and a signed embryo transfer agreement.

7. **CONDITIONS:** Stallion service will be provided only to healthy mares in sound breeding condition, as determined by a veterinarian acceptable to Stolen Aces Farm.

8. BUYER RESPONSIBILITY: Buyer is responsible to pay any registration or nomination fees associated with AMHA to complete registration on any foal(s) born from the Frozen Semen.

9. NON-ASSIGNMENT: This contract cannot be assigned or transferred by Purchaser. There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership after having been served by the Stallion.

10. WARRANTY: Seller is not responsible for lost, delayed, or damaged semen and makes no representations or warranties of any kind with respect to any semen furnished hereunder except that it is the Stallion's. There is no LFG on the semen as it is sold on a per dose basis. ALL WARRANTIES OR MECHANABILITY AND FITNESS FOR PURPOSE ARE HEREBY EXCLUDED.

11. GOVERNING LAW: This contract shall be governed by the laws of the State of Nevada shall be binding upon the parties hereto and their personal representatives.
