BREEDING CONTRACT

2026

This contract is made and entered by and between the Stallion Owners, **Shelley and Robert Bullard, 12145 SW Madrona Ridge Dr., Hillsboro, OR 97123**, (hereinafter Stallion Owners) and _____ (hereinafter Purchaser) for the breeding of the Mare named: _____ Registration number: _____ to the Stallion, **TRICKLING STREAM MY DREAM** AMHA # 207564 for breeding via frozen semen stored at Oakhurst Equine Services (hereinafter Oakhurst) in Newberg, OR, subject to the following terms and conditions:

1. Through their winning bid in the 2026 MHAO Stallion Service Auction, Purchaser has paid the non-refundable Stallion Service Fee for one breeding to TRICKLING STREAM MY DREAM. **The stallion service fee covers three (3) doses of frozen semen** from the above-named stallion in this calendar year.
2. In the event that the mare does not conceive after the third breeding cycle, **return privileges are guaranteed through 2027 at the expense of \$100 per dose** for up to two additional doses (up to 8 straws per dose) made payable to the Stallion Owners, in addition to any fees incurred by Oakhurst. Payment is due before shipment of additional semen.
3. Shipments of semen will be made from Oakhurst (503-554-0227). **Shipping costs and all related fees will be at the expense of the Purchaser and will be billed by Oakhurst directly to Purchaser.** Purchaser agrees to follow Oakhurst payment guidelines prior to shipment. NO SEMEN WILL BE SHIPPED BY OAKHURST WITHOUT PAYMENT FIRST.
4. **The Stallion Owners are not responsible for lost, delayed, or damaged semen** and make no representations or warranties of any kind with respect to any semen furnished hereunder except that it is the Stallion's.
5. Should the Mare described herein die before or after breeding or become unfit for breeding, **Purchaser may substitute another mare with the written consent of the Stallion Owners.** There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership.
6. A copy of **the Mare's registration papers MUST BE RETURNED to the Stallion Owners with the completed Stallion Service Contract PRIOR to breeding.** Purchaser understands that the mare and the resulting foal must be blood typed by the American Morgan Horse Association prior to the registration of the foal. Any foal conceived in any manner that does not comply with this contract will not be eligible for registration.

7. Should the Mare not produce a live, viable foal (defined herein as one that stands and nurses on its own within 24 hours) return service in the following season will be granted by the Stallion Owners provided proper notification is given and payment of related fees is made. **The LFG covers two (2) additional doses of frozen semen from the above named stallion at no charge**, with the exception of handling and shipment fees from Oakhurst, which fees will be billed directly to the Purchaser.
8. "Proper Notification" as referred to in #7 above **requires written notice certified by a veterinarian be given to the Stallion Owners within seven (7) days** that the mare has slipped or produced a non-viable foal; and, Purchaser certifies that such abortion or death did not result from any act or omission of the Purchaser and that all due care was exercised and the mare was afforded reasonable protection.
9. This Agreement shall be governed by the laws of the State of Oregon, and shall be binding upon the parties hereto. This contract constitutes the entire agreement of the parties and no other agreements, whether verbal or implied, are included. Upon signing by BOTH the Purchaser and the Stallion Owners, this contract will be binding on both parties, subject to the above terms and conditions.
