#### THE OWNER DOES HEREBY AGREE TO HAVE THE MARE BRED TO BURKLAND TOUGH ENOUGH UNDER THE FOLLOWING TERMS AND CONDITIONS:

- THE BREEDING FEE SHALL BE \$1,800 AND SHALL BE PAID BY OWNER TO AGENT AT TIME OF BOOKING. ALL FEES MUST BE PAID IN FULL TO
  41 DEGREE INVESTMENTS LLC PRIOR TO SHIPMENT OF SEMEN.
- IN THE EVENT MORE THAN ONE FOAL IS CONCEIVED, EACH FOAL MAY BE DULY REGISTERED WITH THE AMERICAN MORGAN HORSE ASSOCIATION. A FEE OF \$1.800 IS DUE WITHIN 30 DAYS OF ANY ADDITIONAL FOAL RESULTING IN THE USE OF THIS SEMEN.
- OWNER SHALL ASSUME ALL RESPONSIBILITY FOR THE CONDITION OF THE MARE AND ALL THE RISK OF LOSS OR DAMAGE TO THE MARE WHETHER DEATH, DISEASE, INJURY, INFECTION, OR OTHERWISE, AND BY ANY CAUSE WHATSDEVER AND THEREFORE AGREES TO HOLD THE AGENT (OR PERSON EMPLOYED BY OR ASSOCIATED WITH THE AGENT) HARMLESS FOR ANY AND ALL DAMAGES ASSOCIATED THEREWITH.
- DUE TO THE MANY VARIABLES INVOLVED WITH SHIPPING AND BREEDING PROCESS THAT ARE BEYOND OUR CONTROL ONCE THE SEMEN

- THIS CONTRACT CANNOT BE ASSIGNED OR TRANSFERRED BY OWNER WITHOUT THE WRITTEN CONSENT OF AGENT.
- DWNER MAY NOT SELL THE SEMEN
- A SUBSTITUTE MARE MAY BE USED UPON THE APPROVAL OF AGENT
- THIS CONTRACT OFFERS A LIVE FOAL GUARANTEE WITH A TWO-YEAR RETURN PRIVILEGE. OWNER IS RESPONSIBLE FOR ALL ADDITIONALS
   SHIPPING COSTS, IF MARE DOES NOT SETTLE AFTER TWO YEARS, CONTRACT IS NULL.
