1. Total stud fee for the 2022 breeding season is \$750.00, which must be paid in full before the semen is shipped.
2. Should said Stallion die, become unfit for service, or sold, the stud fee will have return privileges to another stallion standing at Harlan & Tammy Grunden's.
3. Harlan and Tammy Grunden guarantee a live foal from the mating, meaning the foal shall stand and nurse. Should foal not exist or dies at birth, the mare owner will be entitled to a return privilege for the same mare this year or the following year only.

4. The mare owner will be responsible for expenses occurred for shipping more semen if the mare did not settle.

**5. TERMS OF SHIPPING SEMEN**

The cost of shipping will be actual cost.

If the semen shipping container is not returned in original sanitary condition to Grunden Ranch Morgans within seven business days after Owner receives the container, late fees of \$10.00 per day will assessed.

The mare Owner will return the container within one week of receiving or will be charged for another shipping container.

6. Additional stud fee(s) will be payable in the event:

(a). Additional mares are inseminated with a resulting foal or

(b). Embryo transfer produces more than one foal.
