Semen Transport:

The mare owner certifies that the veterinarian contracted to inseminate the said mare, as listed above, practices equine reproduction as a regular part of his/her practice, is available for palpations, cultures, and other necessary procedures and has consented to oversee the breeding of said mare on a regular basis. The mare owner also agrees to the following:

1. The mare should be examined no earlier than 30 days prior to shipment of semen and found free of infection and in good breeding condition.
2. The mare owner must contact the stallion owner **at least** 48 hours prior to needing the shipment so the arrangements can be made for the collection.
3. The veterinarian should examine the mare for pregnancy between 16 and 18 days after breeding to determine if there is a viable pregnancy.

Semen Transport Charges:

The semen transport fee of \$350.00 is due to Abrahams Equine Clinic Prior to collection and shipment of semen. This fee covers the cost of shipping as well.

There is no container charge but Abrahams asks to have their box mailed back to them at the earliest convenience.

Return Privileges:

If the mare absorbs or aborts and cannot be covered during the current breeding season, or if the mare does not produce a live foal (defined as one that stands and nurses within 24 hours), Over-Time Morgans agrees to rebreed the same mare or an alternate approved mare during the next year's breeding season providing that a licensed veterinarian concurs that the mare aborted or did not have a live foal. If the mare or an alternate is not re-bred within the following year, then all return privileges will be canceled. If after 2 breeding seasons, a viable pregnancy resulting in a live foal are not obtained, the stallion owner reserves the right to cancel or re-negotiate the contract and additional fees are possible.

Services Not Completed:

If the stallion at any time becomes unfit for service, or dies before service, this contract will become null and void and the stud fee will be returned unless purchased through a stallion service auction. No alternate stallion will be available at this time.

Venue, Costs, and Attorney Fees:

It is further agreed that in the event it is necessary for Over-Time Morgans to hire an attorney to enforce the terms of this contract or to defend against an action brought by the mare owner, whether or not it results in a lawsuit filed in a court of competent jurisdiction, Over-Time Morgans shall be entitled to reimbursement of attorney fees and costs by mare owner. In the event it is necessary to resort to a court of law in order to enforce the terms of this contract or to defend against an action from the mare owner it is agreed between the parties that the venue of said court action shall be exclusively limited to the county of Whiteside, State of Illinois.

Any foal conceived in any manner not complying with the contract will not be eligible for registration.

By signing this contract both parties agree to consider it legally binding and valid even though it is not notarized:
