Mare Breeder does hereby agree to have the mare bred to **After Dark Gunsmoke** for the **2022** breeding season under the following terms and conditions:

1. The breeding fee shall be **\$850** and is divided into two parts that shall be paid by the Breeder to the Owner/Agent of After Dark Gunsmoke as follows:
 - a. **\$200 Booking Fee** Payable to **Silver Mesa Morgans**, due at the time of booking and execution of this contract. This Booking Fee is *non-refundable*. Should re-booking be required, an additional \$200 Booking Fee will be charged,
 - b. **\$650 Breeding Fee** Payable to **Silver Mesa Morgans**, due to be paid prior to the first semen shipment,
2. Collection and/or preparation fees will be invoiced directly from our vet of choice.
3. Shipping charges will be added prior to each dose shipped,
4. Live Cover WILL REQUIRE a negative uterine culture.
5. Mare care for Live Cover will be billed at \$15/day.
6. Mare owner agrees to be responsible for ALL potential additional veterinarian fees incurred for said mare.
7. This contract is for the mare named above ONLY. All parties agree that semen shipped under this contract provides for the registration of **ONE** foal. If this shipment results in the birth of two foals, an additional stud fee of \$850 will be due within 30 days of foaling,
8. The mare owner shall assume all responsibility for the condition of the mare and all risk of loss or damage to the mare whether death, disease, injury, infection or otherwise and by any cause whatsoever and therefore agrees to hold the stallion manager and/or owner (or any

person employed by or associated with the stallion manager and/or owner) harmless for any and all damages associated therewith,

9. The contract allows for up to **three** breeding doses to be shipped as needed within the same breeding season. If a live foal is not produced within this breeding season, Breeder may re-contract at the already paid breeding fee for **2023** ONLY, with the aforementioned collection and shipping fees. Requests for re-booking for **2023** must be done within the **2022** calendar year – failure to do so will result in loss of all fees paid.

This contract cannot be assigned or transferred by Breeder without written consent of Owner/Agent.
